## **Summer Road Repair Grant**

Dear Silver Shekel Property Owners,

We are pleased to announce that Summit County has awarded Silver Shekel funding to repair the Summer Road. The amount of the grant from the Community Wildfire Prevention Program is about \$32500 and we are obligated for an additional \$3700 for a total project cost of about \$36,200. This is enough to do the following:

- 1. Repair the drainage, including the ditches and culverts. One culvert will be replaced and the rest cleaned.
- 2. Remove the patches of recycle asphalt.
- 3. Install and compact road base material and treat with mag chloride.
- 4. Install signage at both ends (No County Mtce/Travel At Your Own Risk and No Trucks/No Trailers signs).

We have contracted with a company to do the project and the work should be completed in August.

Because the road base/mag chloride combination is not permanent, we will still need to maintain the road each year, but the costs will be much less.

This project is in lieu of a much more expensive project that would have paved the road and resulted in a one-way only exit onto Hwy 9. To do this, we would have needed additional funding from the property owners, and the <u>survey results</u> last winter were clearly against that approach.

More details will be given at the Annual Meeting on July 8th.

Please plan to attend the Annual Meeting and BBQ, either in person (we would love to see you there) or by proxy (which would be OK, too). If you can't be there in person, please send us your proxy. The form is attached.
