Results of 2025 Silver Shekel Survey

Dear Silver Shekel Property Owners,

Thank you for completing the 2025 Silver Survey! We had very good participation with 109 responses, and we want to share with you the results. Please see the attached pdf file.

As a result of the survey the Board has taken two decisions related to Clean-up Day. One was to sponsor Garage Sale/Free Stuff days one week before Clean-up Day. This will give residents the opportunity to re-purpose useful items, either at their own garage sale or by placing them on the roadside for free. This could, we believe, reduce significantly the amount going into the landfill in our roll-off dumpsters the following weekend.

The second decision was to reduce the number of roll-off dumpsters from three to two for this summer's Clean-up Day. We will communicate more about this, including the locations, before Clean-up Day.

The survey also showed strong interest in recycling Hard to Recycle items and residents are encouraged to use Summit County Resource Allocation Park (SCRAP) near Keystone to dispose of these items. It is free to County residents. [Click here for more information.](#)

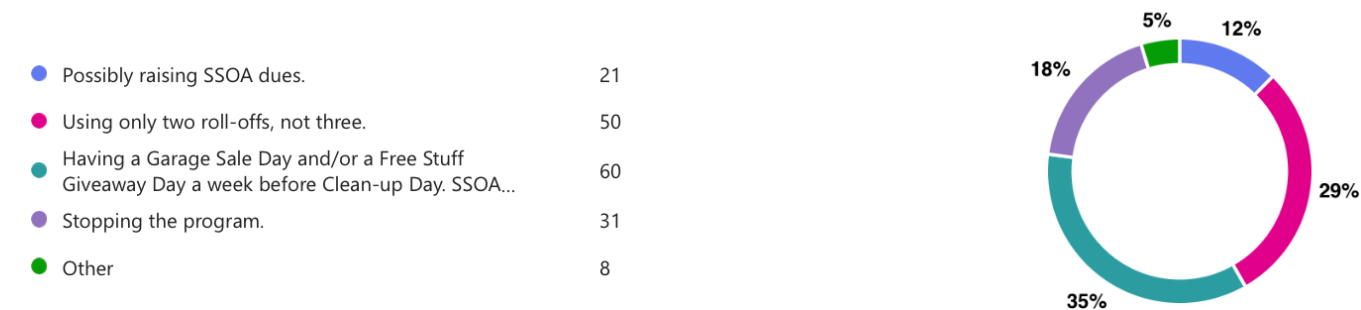

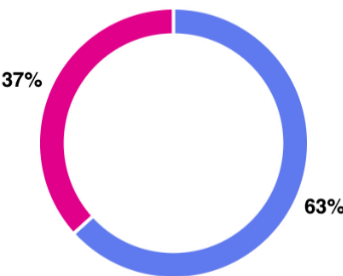

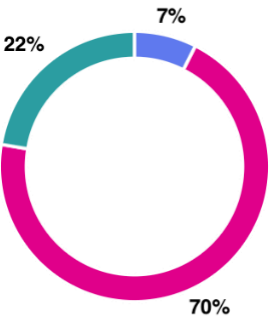

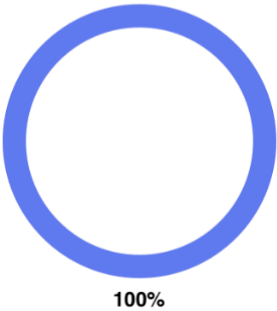

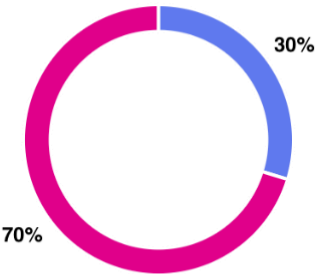

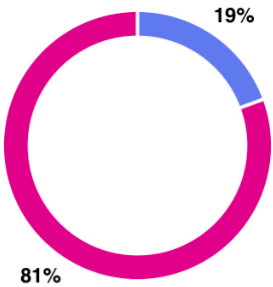
