
# Silver Shekel 2025 Survey Results



1	anonymous	Clean up day is helpful! I appreciate having it has an option.
2	anonymous	I'm not always here on the day scheduled so can't take advantage.

4	anonymous	County has a Hazmat materials free drop off day (late May) that is already in place

15	anonymous	The county does have an annual "hard to recycle" collection event and the Land Fill does take these items. Maybe more education around them would help.


16	anonymous	There is a county wide day where people can drop this stuff off at the county barns







# 12. Please give us any comments you have about social programs.


12	anonymous	I enjoy the picnic with the annual meeting






# 15. Do you rent it?




16. Do you rent out a portion of your home (a separate apartment or a room)?


17. Is the rental short-term or long term? (Short term is considered any consecutive rentals less than 30 days each).

ID ↑	Name	Responses
1	anonymous	There are a couple houses on silver circle that constantly have cars parked on the street. It would be great if the board can help enforce /remind residents they can't park on county roads. And/or have the county come and ticket vehicles doing it repeatedly.
2	anonymous	How much has the cost of the dumpsters increased?
3	anonymous	Would love to see if the neighborhood is majority part timers if we could would with the county to explore the rental rules for our neighborhood. We would love to rent a couple weeks during ski season but currently can only do monthly. Since we live there all summer and come up once a month we will not be renting to a local looking for housing but the county is missing out on tax revenue as a result. But only if others in neighborhood are open to this. Maybe also finding a deal on snow removal from a local contractor? Also would love a group to keep people aware of fire prevention, maybe a fire prevention clean up day? And finally would love to know what people are doing about insurance. Maybe someone that could advise us all on steps yo help reduce insurance rates
4	anonymous	The HOA fee is RIDUCULOUSLY low. We could do so much better if people would just open up a little more. We also need a "fire risk assessment" with action items in light of the ongoing threat and the potential for human-initiated fires from changing populations that might inhabit Summit County (campfires).

12	anonymous	I think we should really discuss getting all the full time residents who have a weekly trash service to contact Trash Gurus (they are the least expensive I have found) to do a group contract and see if we can get the cost down as a neighborhood group rate. Same with snow removal? Who has the best weekly snow removal company? I have seen other homes having driveway snow removal by someone different than ours and would love to see if we can find the best one and see if we can get a deal so they can hit multiple driveways in the neighborhood.	
13	anonymous	Some of the answer choices did not fit me. I am almost full time and certainly heading that way. I do not rent my home.	
14	anonymous	Low key and low impact HOA is very much appreciated. Minimize requirements while strengthening the neighborhood.	
15	anonymous	As far as trash receptacles, are they supposed to be kept inside (enclosure/garage) in between pick up - due to bears etc? Also, in that regard, aren't they not supposed to be put out until day of service and taken off street within 24 hours? Can the board put out a notice (email) to all homeowners what exactly the rules are ?	
16	anonymous	We have a deed restricted accessory dwelling unit that is rented to a local resident. We also do limited short term rentals of our primary residence. I do not agree with the boards criticism of the round about. Based upon the fatal/serous accidents that have happened at Tiger Road and Swan Mountain Road over the last year, I think our round about is safer than a light would be. You have to be careful and assume people are not going to stop, but I think it is safer and saves a lot of time. I also think the boards comments on the moving the free skier parking were not accurate. It would not increase traffic in the round about. Same number of cars would still go through - they may just enter from a different direction. It may increase safety since cars coming from the West would help to slow northbound traffic.

This would also serve as an additional exit for residents in second and first filings in the case of an emergency evacuation. Two exits are not enough for the number of households in Silver Shekel. Please give this deep consideration for everyone's safety.
